Establishing Protected Forest and Biodiversity Conservation "Prey Long"

- Haing seen the Preah Reach Kret N° NS/RKT/0908/1055 of September 25, 2008 on the Appointment of the Royal Government of the Kingdom of Cambodia;
- Having seen the Preah Reach Kram N° 02/NS/94 of July 20, 1994, promulgating the law on the organization and functioning of the Council of Ministers;

- Having seen Sub-decree N°188/ANK/BK of November 14, 2008 on Revising the General Directorate of Ministry to be Secretariat General, Promoting the Forestry Administration and the Fishery Administration to be equal to the level of General Directorate, Promoting Department of Agronomy and Agricultural Soil Improvement to General Department of Agriculture, and Revising General

Directorate of Rubber Plantation to General Directorate of Rubber under the Ministry of Agriculture, Forestry and Fisheries.

HEREBY DECIDED

Chapter 1 General Provisions

Article 1: The sub-decree is aimed at establishing protected forest for biodiversity conservation "Prey Long" located in Kratie, Kampong Thom, Preah Vihear, and Steung Treng province.

Article 2: The objectives of the sub-decree are:

- To Protect and conserve fauna and flora and endangered species
- To stabilize environment and restore damaged ecosystem for safety habitat and reproduction of biodiversity
- Participating in protection and conservation in accordance with Government development plan on management and forest cover preservation
- To preserve the traditional and religious of local community inside protected forest
- To keep using of natural resource of local community for livelihood improvement
- To develop sustainable socio-economic by managing and using forest resource of local community, ecotourism development, ecotourism, and other uses lower effected to biodiversity, forest and wildlife
- To preserve carbon stock in all plant species to reduce CO₂ emission to atmosphere
- To mitigate climate change by protecting forest
- To protect soil erosion, soil nutrition, flood, water resource and water quality
- To support other activities such as research and technical for development, watershed conservation and biodiversity, education, training, community development and investigating on environmental change related to sustainable development and local, national, and sub-national conservation.

Section 2 Location

Article 3: Protected forest and biodiversity conservation "Prey Long" covers 480,000 hectares located in Kraties, Kampong Thom, Preah Vihear, and Steung Treng province with coordinate system as below:

Article 4: Protected forest and biodiversity conservation "Prey Long" located in Kraties, Kampong Thom, Preah Vihear, and Steung Treng province referred in the Article 3 of the subdecree can be revised if necessary depending on scientific study in basic techniques and real situation.

the revision is limited by sub-decree.

Section 3 Management

Article 5: Protected forest and biodiversity conservation "Prey Long" is preserved strictly in order to prevent ecosystem including water resource, biodiversity conservation, land water, soil nutrition, watershed, shelter, culture and soil erosion.

Local community living inside or outside the protected forest referred in the subdecree is protected and recognized their traditional use and community ecotourism development in accordance with the law and relevant provisions still in force.

Article 6: The activities are not allowed in protected forest and biodiversity conservation "Prey Long" in the following:

- clearing, burning and forest land conversion to be ownership
- Settlement and construction without permission from the government
- Construction the road without the feasibility study or permission from the government
- Forest products processing or the establishing and developing industry, handicrafts and kilns
- Mining, burning for cement or charcoal or digging salty soil
- Clearing and agricultural forestland conversion or all tree species
- Collecting wood, NTFPs and hunting affected to forest and wildlife

Article 7: The Ministry of Agriculture, Forestry and Fisheries has the duty to arrange and manage Protected forest and biodiversity conservation "Prey Long" located in Kraties, Kampong Thom, Preah Vihear, and Steung Treng province in cooperation with relevant ministry, stakeholders and local authorities in conservation and sustainable natural resource development for local livelihood in Protected forest and biodiversity conservation "Prey Long".

Protected forest and biodiversity conservation "Prey Long" arrangement and management is determined by Prakas of the Ministry of Agriculture, Forestry and Fisheries.

Chapter 3 Final Provisions

Article 8: Any provision, contrary to this sub-decree, shall be null.

Article 9: Minister in charge of the Council of Ministers, minister of Ministry of Economy and Finance, minister of Ministry of Agriculture, Forestry and Fisheries, minister of Ministry of Environment, minister of The Ministry of Land Management, Urban Planning and Construction, minister of Ministry of Tourism, ministers and secretaries of state of all relevant ministries, institutions and the governor of

Kratie, Kampong Thom, Preah Vihear, and Steung Treng shall be implemented this sub-decree from the dates of its signature
